Committee Request for Board Action

In July 2005, the BAPPG presented two workshops (workshop summary attached) to Bay Area Hospitals entitled, "Navigating Pharmaceutical Waste Management in Medical Facilities." Hospital representatives left that workshop wanting more guidance on the proper disposal of pharmaceuticals. In April 2006, Hospitals for a Healthy Environment (H2E) released the national document "Managing Pharmaceutical Waste: a 10-Step Blueprint for Health Care Facilities in the United States" that includes federal guidelines.

BAPPG has received approval from H2E and is proposing to update their document to include California-only hazardous waste regulations (expands the number of pharmaceuticals considered hazardous) and to direct that pharmaceuticals should NOT be sewered. To that end, BAPPG is requesting approval for the following:

- a. Approval of 2007/2008 BAPPG Budget Revision (allocating \$4,600 from 2006/2007 unspent budget to the H2E document update) see attached revised 07/08 budget
- b. Approval of PharmEcology Purchase Order for \$6,000 to update the H2E document
- c. Approval of Purchase Order for \$3,600 for Systems Improvement Initiators, Inc. to update the H2E document
