Enclosed you will find the Bay Area Clean Water Agencies (BACWA) 2008 Mercury Watershed Permit Group Report. This is the first annual report under the Mercury Watershed permit which implements the Mercury TMDL. Completed forms for participating agencies are included in Appendix A. The report is being submitted in both a hard copy and electronic format.

The permittees in the BACWA group have opted to submit their annual report through the BACWA group, according to Section IV.C. in Attachment E of the mercury watershed permit (page E-7). As indicated in the permit, this group reporting is an alternative to the individual reporting indicated in section IV.B.2.b. of Attachment E. The attached report also covers the requirement under Attachment E. IV C 2, Report on Mercury Reduction Efforts.

On March 1, 2009 BACWA submitted two other reports required by the Mercury Watershed Permit, these were a progress report for the risk reduction communication program required under section V.C.4 and a report on special studies required under section V.C.3.a. With the combination of the attached report and the two reports submitted on March 1, 2009, BACWA has fulfilled the four reporting requirements of the watershed permit; the effluent reporting, the pollution prevention (mercury reduction efforts) reporting; the risk reduction and the special studies reporting.

BACWA members own and operate publicly-owned treatment works (POTWs) that discharge to San Francisco Bay and its tributaries. Collectively, BACWA members serve over 6.5 million people in the nine-county Bay Area, treating domestic, commercial and industrial wastewater. BACWA was formed to develop a region-wide understanding of the watershed protection and enhancement needs through reliance on sound technical, scientific, environmental and economic information and to ensure that this understanding leads to long-term stewardship of the San Francisco Bay Estuary. BACWA member agencies are public agencies, governed by elected officials and managed by professionals who are dedicated to protecting our water environment and the public health.
