- The topics brainstormed and then categorized were:
 - Interface of Regulatory Engineering Issues 1.
 - Information Management to Support Engineering Automation 6
 - Recruiting/Retention for in-house team 5
 - o Bigger issues for public agencies
 - Quality of work from consultants
 - Treatment Process Engineering Issues 2
 - Decision on when to repair vs. replace (lifecycle) 2 and 3
 - Laterals 3

- Collection System design/size (includes regulatory issues) 3
- Treatment plant capacity in wet weather 2
- Encroaching residential/commercial development (and odor) 4
- Residential deinstensefication and new commercial development -4
 - o Permitting and development services
 - o Strain on collection and treatment systems
- Large CIP decisions on in house vs. outsourcing of engineering work – 1,2,3,4
 - o Out sourcing and creating efficiencies
 - o Collaboration among EIS group
- Conceptual and Full planning of new capital projects 7
- Development of grants and developer funding 7
- Flooding and Storm water 2,3
