Motivations for NbS in the Bay Area


- 1. Anticipated flood risk




High Potential (18)



Medium Potential(12)



NBS Concepts SOUTHERN MARIN



Option 1: Coordinate with Bothin Marsh Evolving Shorelines project on a horizontal levee behind North Bothin Marsh Option 2: Construct horizontal levee adjacent to the equalization basins, behind Mill Valley Marsh

Option 3: Dual-purpose wet-weather equalization and open water wetland with seepage slope sides

NBS Concepts



Option 1: Convert former recycled water basins into train of open water wetlands optimized for various purposes

Option 2: Dual-purpose wet-weather equalization and open water wetlands with seepage slope sides

Option 3: Convert existing alfalfa field to open water wetland or hybrid seepage slope/open water wetland

Option 4: Convert dry-farming area to open water wetland or hybrid seepage slope/open water wetland

Option 5: Partner with/purchase one or more neighboring duck club properties and convert to temporary freshwater wetland to build peat (elevation) to prepare for future tidal restoration

(3 mi SW) Option 6: Coordinate with Pacific Flyway Center to provide wastewater effluent for habitat creation efforts

NBS Concepts DELTA DIABLO

Option 1: Convert part or all of the equalization/stormwater basin to open water wetlands Option 2: Convert the newly purchased property southwest of the plant to an open water wetland Option 3: Coordinate with BNSF and Corteva Preserve to construct horizontal levee north of rail line



NBS Concepts CENTRAL CONTRA COSTA

All assuming development of a suitable nitrified effluent stream



Option 1: Convert Basins C, D, or both to open water treatment wetlands

Option 2: Convert Basin A North into a serpentine channel-type open water wetland

(1 mi N) Option 3: Coordinate with the Lower Walnut Creek Restoration Phase II (Middle Reach) on a horizontal levee



NBS Concepts UNION SAN



Option 1: Coordinate with SBSPRP/CDFW on beneficial use in the restoration of Pond E6

Option 2: Coordinate with SBSPRP/CDFW to construct a horizontal levee at the back of Pond E6

Option 3: Coordinate with ACFCWCD to construct open water wetlands in one or more diked basins

Constraints

- Grey infrastructure is faster & sometimes cheaper
- Limited funding for flood risk, habitat & stormwater management
- Anticipatory action is hard to justify
- Equity & community engagement is unfamiliar
- Land is scarce & expensive
- Working across landowners is cumbersome
- Long-term maintenance is uncertain



Opportunities to Advance NbS

- 1. Lots of funding (State, Federal & Local grants)
- 2. Increased regulatory clarity from Water Board
- 3. EPA Nutrient Memo encouraging multi-benefit strategies

Water Board Permitting Framework

- Discharge points
- Exceptions to discharge prohibitions established in the Basin Plan
- Effluent limitations
- Operations & maintenance
- Compliance determination
