On behalf of Napa Sanitation District (NapaSan), I have reviewed the Nature-Based Solutions for Nutrient Removal – Opportunities & Constraints Analysis. The Evaluation was prepared by the SFEI consulting team (Consultants) under a contract with the Bay Area Clean Water Agencies (BACWA), in compliance with the 2019 Nutrient Watershed Permit (Order No. R2-2019-0017, NPDES No. CA0038873) on behalf of the Dischargers. A representative group of BACWA members (i.e. Contract Management Group) also provided direction to the Consultants in preparing the individual plant reports and the overall summary for the Evaluation.

NapaSan was contacted by the Consultants in 2021 and our facility was not recommended for inclusion in the Phase 2 site-specific evaluations.
